Conclusion

U - sit 71 armchair (with backscreen & Armrest) **complies** with the standard EN 16139:2013 including corrigendum EN 16139:2013/AC:2013 (Furniture – Strength, durability and safety – Requirements for non-domestic seating) level of test severity L1 requirements.

Test object

U - sit 71 armchair (with backscreen & Armrest) with soft seat, backrest, armrests, backscreen and metal legs. Frame of seating, backrest, armrests are made of particle board and plywood. Seat, backrest, armrests and backscreen are padded with foam and upholstered with tapestry. Height of soft part of seat is 80 mm, of backrest – 100 mm, of armrest - 10 mm, of backscreen - 5 mm. Legs are welded of (40x20) mm metal tubes and (100x100) mm metal plate, fixed with screws (5x37) mm. Height of legs – 195 mm, length – 600 mm. Armrest fixed with bolts M8.

External dimensions are: length 800 mm, depth 750 mm, height with backscreen 1450 mm. Height of seat – 460 mm. Description is for general information.
